

Internship in veterinary clinical sciences (I.P.S.A.V. – Program 259017) 2024-2025

POSITION: EQUINE INTERNAL MEDICINE

NUMBER OF POSITIONS AVAILABLE: 1

DESCRIPTION:

This rotating internship in veterinary clinical sciences is an intensive graduate training program of 12 months (53 weeks) duration. A certificate is awarded upon completion of the program. The program mainly consists in clinical training in equine internal medicine (internal medicine, neonatology, equine ophthalmology), and participation in clinical teaching rounds and teaching laboratories. This specialized internship includes participation in clinical teaching, journal clubs, and admission of day-time appointments and emergencies. The internship takes place at the Centre Hospitalier Universitaire Vétérinaire (CHUV) and the intern will participate to the admission of after-hours emergencies and the out of hours care on a rotating basis (according to the terms of the equine hospital). A few rotations in other services will take place for a more complete training (anesthesia, imaging). Participation to a research project leading to a publication will be encouraged. Interns are eligible for 3 weeks of vacation determined by the hospital. Veterinary medical activities performed outside the internship program must be declared to the associate dean of clinical studies.

REQUIREMENTS:

- Doctor of Veterinary Medicine (DVM) or equivalent
- License to practice
- · Internship in French

TUITION FEES (Amounts shown are in Canadian currency):

- Quebec, Canadian outside Quebec and French/French-speaking Belgian students = On average \$5,835/year
- International students = On average \$22,701/year, including the UdeM exemption scholarship

SALARY: The candidate receives \$ 19 500 for 53 weeks. To these amounts are added 1 287 \$ (3.6 % for the payment of public holidays and 3 % for benefits).

Intern responsibilities:

- (1) Out-of-hour duties based on the clinical schedule;
- (2) Patient care during undergraduate student's vacation;
- (3) Clinical teaching duties.

<u>PROGRAM DURATION</u>: July 10th, 2024 to July 16th, 2025 (For the intern on call, the program will end at 8:00 am the next day). **Late admissions due to delays in permits for international students will be considered.**

 by the Université de Montréal and need to return the completed form. No other forms or reference letters will be needed;
- Students who have completed a clinical rotation at our Veterinary Teaching Hospital (CHUV) must provide their evaluation with their application for admission.

CANDIDATE SELECTION

The selected candidate will be contacted on **May 15th**, **2024**, **8:00** am by phone and email. The candidate will have 24 hours to accept or decline the position. If a candidate withdraws, the next candidate on the rank list will be contacted until all positions are filled. The rank list will not be disclosed. This process can take several days. Candidates on the waiting list and candidates not selected will be notified by email.
