**POSITION: FARM ANIMAL MEDICINE AND SURGERY: HOSPITAL FIELD SERVICE PRACTICE**

**NUMBER OF POSITIONS AVAILABLE: 2**

**DESCRIPTION:**

This internship in veterinary clinical sciences is an intensive graduate training program of 12 months (53 weeks) duration. A certificate is awarded upon completion of the program. The program includes clinical training and participation in clinical teaching rounds and teaching laboratories of our senior students. The interns will perform clinical exams and will participate in the elaboration of the diagnostic and therapeutic plans of hospitalized patients. Interns will work in the Centre Hospitalier Universitaire Vétérinaire (CHUV) and will be supervised by clinicians. Interns will participate in the after hour on call rotation (one every three weeks). The teaching personnel supervising the resident is composed of 2 professors diplomate of the ACVIM, 3 professors diplomate of the ACVS and 1 professor diplomate of the ECBHM. Interns are eligible for 3 weeks of vacation determined in collaboration with the program director. Any professional activities performed outside the internship program must be declared to the Associate-Dean of clinical affairs.

**REQUIREMENTS:**

- Doctor of Veterinary Medicine (DVM) or equivalent
- License from the Ordre des Médecins Vétérinaires du Québec before starting the program (ideally)
- French speaking and writing

**SALARY: The candidate receives \$ 19 500 for 53 weeks. To these amounts are added 1 287 \$ (3.6 % for the payment of public holidays and 3 % for benefits).**

A 2% contribution of gross salary will be deducted for union dues. Salary and conditions will follow the agreements stipulated in the collective agreement.

Intern responsibilities:

- (1) Out-of-hour duties based on the clinical schedule;
- (2) Patient care during undergraduate student's summer semester ;
- (3) Clinical teaching duties.

**PROGRAM DURATION:** July 8<sup>th</sup>, 2026 to July 14<sup>th</sup>, 2027

- Students who have completed a clinical rotation at our Veterinary Teaching Hospital (CHUV) must provide their evaluation with their application for admission.

**Candidate selection**

The selected candidate will be contacted on **February 2<sup>nd</sup>, 2026, 8:00 am** by phone and email. The candidate will have 24 hours to accept or decline the position. If a candidate withdraws, the next candidate on the rank list will be contacted until all positions are filled. The rank list will not be disclosed. This process can take several days. Candidates on the waiting list and candidates not selected will be notified by email.
